I know hunting and shooting is considered by many to be dangerous and I hereby assume the risk of any and all injuries I may suffer due to the physical condition of Peaceable Hill Farm, the acts of omissions of other hunters or shooters who may be on or near Peaceable Hill Farm, whether with or without permission, equipment failure, acts of God and/or for any other reason.

I have been advised that there may be other persons hunting, shooting or carrying firearms on Peaceable Hill Farm, and I agree to act prudently and carefully to avoid causing them any injury. I certify that I am familiar with the use and operation of the firearm(s) I will be using while on Peaceable Hill Farm and that I am familiar with the rules of hunting and shooting. I hold a valid hunting license in the State of _____, and or an approved Hunter Safety certificate.

I release Peaceable Hill Preserve LLC, Glenn & Judith Symon and Peaceable Hill Farm, together with all their employees, agents and representatives from any and all claims for personal injury, wrongful death, and/or property damage which I may have or which may occur during or as a result of my presence on Peaceable Hill Farm as referenced above regardless of the cause of any such injury and including those which may be caused by the negligence of others including the released individuals and entities.

I give this release and assume all the risks attendant thereto in consideration of being allowed to enter into and shoot on Peaceable Hill Farm.

This "release and assumption of risk" will be binding on my heirs, executors and assigns.
